CONSENT  
AGREEMENT  
AND ORDER

**LEIGHTON SEATON PERRINS, M.D.**, (Respondent) representing that all of the following statements are true, deposes and says:

That on or about March 6, 1990, I was licensed to practice as a physician in the State of New York, and issued License No. 181631 by the New York State Education Department.

My current address is 1525 West Duncannon Avenue, Philadelphia, PA 19141, and I will advise the Director of the Office of Professional Medical Conduct of any change of my address thirty (30) days, thereof.

I understand that the New York State Board for Professional Medical Conduct has charged me with four (4) specifications of professional misconduct.

A copy of the Statement of Charges, marked as Exhibit "A", is attached to and part of this Consent Agreement.

I do not contest Factual Allegations A, B, C, and D and the Fourth Specification, in full satisfaction of the charges against me, and agree to the following penalty:

Five (5) year suspension of my New York State license to practice medicine, stayed, with five (5) years probation to run concurrent and coterminous with the probation set forth in the February 22, 2005, Commonwealth of Pennsylvania, Department of State, State Board of Medicine, Consent Agreement and Order, and any modifications thereof, in accordance with Exhibit B, attached, hereto.

Should I return to the practice of medicine in New York state or in any other jurisdiction where that practice is predicated on my New York state medical license to practice prior to my license being fully restored by the State of Pennsylvania, I shall provide ninety (90) days notice in writing, to the Director, OPMC. The Director in his sole discretion, may impose whatever limitations, or further conditions, he deems reasonable.

I further agree that the Consent Order shall impose the following conditions:

That Respondent shall maintain active registration of Respondent's license with the New York State Education, Department Division of Professional Licensing Services (except during periods of actual suspension), and shall pay all registration fees. This condition shall take effect thirty (30) days after the Consent Order's effective date and will continue so long as Respondent Remains licensed in New York State; and

That Respondent shall cooperate fully with the Office of Professional Medical Conduct (OPMC) in its administration and enforcement of this Order and in its investigations of all matters concerning Respondent. Respondent shall respond in a timely manner to all OPMC requests for written periodic verification of Respondent's compliance with this Order. Respondent shall meet with a person designated by the Director of OPMC, as directed. Respondent shall respond promptly and provide all documents and information within Respondent's control, as directed. This condition shall take effect upon the Board's issuance of the Consent Order and will continue so long as Respondent remains licensed in New York State.

I stipulate that my failure to comply with any conditions of this Order shall constitute misconduct as defined by New York State Education Law §6530(29).

I agree that if I am charged with professional misconduct in the future, this Consent Agreement and Order shall be admitted into evidence in that proceeding.

I ask the Board to adopt this Consent Agreement.

I understand that if the Board does not adopt this Consent Agreement, none of its terms shall bind me or constitute an admission of any of the acts of alleged misconduct; this Consent Agreement shall not be used against me in any way and shall be kept in strict confidence; and the Board's denial shall be without prejudice to the pending disciplinary proceeding and the Board's final determination pursuant to the Public Health Law.

I agree that, if the Board adopts this Consent Agreement, the Chair of the Board shall issue a Consent Order in accordance with its terms. I agree that this Order shall take effect upon its issuance by the Board, either by mailing of a copy of the Consent Order by first class mail to me at the address in this Consent Agreement, or to my attorney by certified mail, OR upon facsimile transmission to me or my attorney, whichever is first. The Order, this agreement, and all attached Exhibits shall be public documents, with only patients identities, if any, redacted.

I stipulate that the proposed sanction and Order are authorized by Public Health Law Sections 230 and 230-a and that the Board for Professional Medical Conduct and the Office of Professional Medical Conduct have the requisite powers to carry out all included terms. I ask the Board to adopt this Consent Agreement of my own free will and not under duress, compulsion or restraint. In consideration of the value to me of the Board's adoption of this Consent Agreement, allowing me to resolve this matter without the various risks and burdens of a hearing on the merits, I knowingly waive my right to contest the Consent Order for which I apply, whether administratively or judicially, I agree to be bound by the Consent Order, and ask that the Board adopt this Consent Agreement.



LEIGHTON SEATON PERRINS, M.D., the Respondent, was authorized to practice medicine in New York state on March 6, 1990, by the issuance of license number 181631 by the New York State Education Department.

**FACTUAL ALLEGATIONS**

A. On or about September 19, 2003, in the New Jersey Superior Court, Law Division, Criminal, Camdem County, Respondent was found guilty, based on a plea of guilty, of Driving While Intoxicated, a misdemeanor, and was sentenced to a \$50.00 VCCB, \$75.00 Safe Streets, \$250.00 fine, \$200.00 surcharge, six (6) month loss of driver's license concurrent with that imposed for the conviction set forth in Paragraph B, below, twelve (12) hours drivers education class, and a \$2.00 A.T.S. fee.

B. On or about September 19, 2003, in the New Jersey Superior Court, Law Division, Criminal, Candem County, Respondent was found guilty, based on a plea of guilty, of Resisting Arrest – Eluding, a felony, and was sentenced to four (4) years probation, 500 hours community service, a \$5,000.00 fine, \$50.00 VCCB, \$75.00 SSA, \$10.00 per month probation supervision fee, and a six (6) month loss of driver's license concurrent with that imposed for the conviction set forth in Paragraph A, above.

C. On or about February 22, 2005, the Commonwealth of Pennsylvania, Department of State, State Board of Medicine, (hereinafter "Pennsylvania Board"), by a Consent Agreement and Order (hereinafter "Pennsylvania Order"), SUSPENDED Respondent's license to practice medicine for five (5) years, stayed the suspension in favor of five (5) years PROBATION, subject to terms and conditions, based on the conviction(s) set forth in Paragraph A and/or B above.

D. The conduct resulting in the Pennsylvania disciplinary action against Respondent would constitute misconduct under the laws of New York state, pursuant to the following sections of New York state law:

1. New York Education Law §6530(9)(a)(iii) being convicted of committing an act constituting a crime under the law of another jurisdiction.

**SPECIFICATIONS**  
**FIRST AND SECOND SPECIFICATIONS**

Respondent violated New York Education Law §6530(9)(a)(iii) by having been convicted of committing an act constituting a crime under the law of another jurisdiction and which, if committed within New York state would have constituted a crime under laws of New York state, in that Petitioner charges:

1. The facts in Paragraph A.
2. The facts in Paragraph B.

**THIRD SPECIFICATION**

Respondent violated New York Education Law §6530(9)(b) by being found guilty of improper professional misconduct by a duly authorized professional disciplinary agency of another state where the conduct upon which the finding was based would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

3. The facts in Paragraphs A, B, C, and/or D.

**FOURTH SPECIFICATION**

Respondent violated New York Education Law §6530(9)(d) by having his license to practice medicine suspended or having other disciplinary action taken by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the suspension or other disciplinary action would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

4. The facts in Paragraphs A, B, C, and/or D.

## **EXHIBIT B**

### **Terms of Probation**

1. Respondent shall conduct himself in all ways in a manner befitting his professional status, and shall conform fully to the moral and professional standards of conduct and obligations imposed by law and by his profession.
2. Respondent shall submit written notification to the New York State Department of Health addressed to the Director, Office of Professional Medical Conduct (OPMC), Hedley Park Place, 433 River Street Suite 303, Troy, New York 12180-2299; said notice is to include a full description of any employment and practice, professional and residential addresses and telephone numbers within or without New York State, and any and all investigations, charges, convictions or disciplinary actions by any local, state or federal agency, institution or facility, within thirty days of each action.
3. Respondent shall fully cooperate with and respond in a timely manner to requests from OPMC to provide written periodic verification of Respondent's compliance with the terms of this Order. Respondent shall personally meet with a person designated by the Director of OPMC as requested by the Director.
4. Respondent shall comply fully with the February 22, 2005, Consent Agreement and Order of the Pennsylvania Board and any extension or modification thereof.
5. Respondent shall provide a written authorization for the Pennsylvania Board to provide the Director of OPMC with any/all information or documentation as requested by OPMC to enable OPMC to determine whether Respondent is in compliance with the Pennsylvania Order.
6. Respondent shall submit semi-annually a signed Compliance Declaration to the Director of OPMC, which truthfully attests whether Respondent has been in compliance with the Pennsylvania Order during the declaration period specified.
7. Respondent shall comply with all terms, conditions, restrictions, limitations and penalties to which he is subject pursuant to the Order and shall assume and bear all costs related to compliance. Upon receipt of evidence of noncompliance with, or any violation of these terms, the Director of OPMC and/or the Board may initiate a violation of probation proceeding and/or any such other proceeding against Respondent as may be authorized pursuant to the law.
