**HARRY J. REED, D.O.**, (Respondent) being duly sworn deposes and says:

That on or about October 10, 1998, I was licensed to practice as a physician in the State of New York, having been issued License No. 212733 by the New York State Education Department.

My current address is 107 5<sup>th</sup> Street, SW, New Prague, MN 56071.

I am currently subject to Consent Order BPMC No. 07-78, (hereinafter "Original Order"), annexed hereto, made a part, hereof, and marked as Exhibit 1, that was issued on April 19, 2007.

I apply, hereby, to the State Board for Professional Medical Conduct for a Modification Order (hereinafter "Modification Order"), modifying the Original Order, as follows: to delete the paragraphs in the Original Order that states:

" Three (3) years probation in accordance with Exhibit B, attached, hereto, to run concurrent and coterminous with the conditions and restrictions imposed by the July 8, 2006, Minnesota Board of Medical Practice, Stipulation and Order, and any extensions and/or modifications, thereof.

Should Respondent return to the practice of medicine in the State of New York or in any other jurisdiction where that practice is predicated upon Respondent's New York State medical license to practice prior to the successful completion of the conditions and restrictions imposed by the State of Minnesota, Respondent shall provide ninety (90) days notice in writing, to the Director, OPMC. The Director in his sole discretion, may impose whatever limitations, or further conditions, he deems appropriate.

That Respondent shall remain in continuous compliance with all requirements of New York Education Law §6502 including but not limited to the requirements that a licensee shall register and continue to be registered with the New York State Education Department (except during periods of actual suspension) and that a licensee shall pay all registration fees. Respondent shall not exercise the option provided in New York Education Law §6502(4) to avoid registration and payment of fees. This condition shall take effect 30 days after the Consent Order's effective date and will continue so long as Respondent remains a licensee in New York State; and"

substituting therefore:

"I shall never activate my registration to practice medicine in New York State or seek to reapply for a license to practice medicine in New York state."


The Modification Order to be issued will not constitute a new disciplinary action against me, but will substitute the proposed language for the above described language in the Original Order.

I make this Application of my own free will and accord and not under duress, compulsion or restraint, and seek the anticipated benefit of the requested Modification. In consideration of the value to me of the acceptance of the Board of this Application, I knowingly waive the right to contest the Original Order or the Modification Order for which I apply, whether administratively or judicially, and ask that the Board grant this Application.

I understand and agree that the attorney for the Bureau of Professional Medical Conduct, the Director of the Office of Professional Medical Conduct, and the Chair of the State Board for Professional Medical Conduct each retain complete discretion either to enter into the proposed Agreement and Modification Order, based upon my application, or to decline to do so. I further understand and agree that no prior or separate written or oral communication can limit that discretion.



**HARRY J. REED, D.O.**, representing that all of the following statements are true, deposes and says:

That on or about October 10, 1998, I was licensed to practice as a physician in the State of New York, and issued License No. 212733 by the New York State Education Department.

My current address is 107 5<sup>th</sup> Street SW, New Prague, MN 56071, and I will advise the Director of the Office of Professional Medical Conduct of any change of my address thirty (30) days, thereof.

I understand that the New York State Board for Professional Medical Conduct (Board) has charged me with three (3) Specifications of professional misconduct.

A copy of the Statement of Charges, marked as Exhibit "A", is attached to and part of this Consent Agreement.

I do not contest the three (3) Specifications, in full satisfaction of the charges against me, and agree to the following penalty:

Three (3) years probation in accordance with Exhibit B, attached, hereto, to run concurrent and coterminous with the conditions and restrictions imposed by the July 8, 2006, Minnesota Board of Medical Practice, Stipulation and Order, and any extensions and/or modifications, thereof.

Should Respondent return to the practice of medicine in the State of New York or in any other jurisdiction where that practice is predicated upon Respondent's New York State medical license to practice prior to the successful completion of the conditions and restrictions imposed by the State of Minnesota, Respondent shall provide ninety (90) days notice in writing, to the Director, OPMC. The Director in his sole discretion, may impose whatever limitations, or further conditions, he deems appropriate.



I ask the Board to adopt this Consent Agreement of my own free will and not under duress, compulsion or restraint. In consideration of the value to me of the Board's adoption of this Consent Agreement, allowing me to resolve this matter without the various risks and burdens of a hearing on the merits, I knowingly waive my right to contest the Consent Order for which I apply, whether administratively or judicially, I agree to be bound by the Consent Order, and I ask that the Board adopt this Consent Agreement.

I understand and agree that the attorney for the Department, the Director of OPMC and the Chair of the Board each retain complete discretion either to enter into the proposed agreement and Consent Order, based upon my application, or to decline to do so. I further understand and agree that no prior or separate written or oral communication can limit that discretion.



STATEMENT  
OF  
CHARGES

HARRY J. REED, D.O., Respondent, was authorized to practice medicine in New York state on October 10, 1998, by the issuance of license number 212733 by the New York State Education Department.

**FACTUAL ALLEGATIONS**

A. On or about November 23, 2004, in the State of Minnesota, District Court, First Judicial District, Scott County, Minnesota, Respondent, was found guilty, based on a plea of guilty, of violating an order of protection, a misdemeanor, and on or about December 20, 2004, was, inter alia, sentenced to probation.

B. On or about July 8, 2006, the Minnesota Board of Medical Practice (hereinafter "Minnesota Board"), by a Stipulation and Order (hereinafter "Minnesota Order"), inter alia, conditioned and restricted Respondent's license to practice medicine for a minimum of three (3) years, based on bi-polar disorder and depression and the conviction set forth in Paragraph A, above.

C. The conduct resulting in the Minnesota Board disciplinary action against Respondent would constitute misconduct under the laws of New York state, pursuant to the following sections of New York state law:

1. New York Education Law §6530(9)(a)(i) (being convicted of committing an act constituting a crime under state law).

**SPECIFICATIONS**

**FIRST SPECIFICATION**

Respondent violated New York Education Law 6530(9)(a)(iii) by being convicted of committing an act constituting a crime under the law of another jurisdiction and which, if committed within this state, would have constituted a crime under New York state law, in that Petitioner charges:

1. The facts in Paragraph A.

**SECOND SPECIFICATION**

Respondent violated New York Education Law §6530(9)(b) by having been found guilty of improper professional practice or professional misconduct by a duly authorized professional disciplinary agency of another state where the conduct upon which the finding was based would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

2. The facts in Paragraphs A, B and/or C.

**THIRD SPECIFICATION**

Respondent violated New York Education Law §6530(9)(d) by having disciplinary action taken by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the disciplinary action would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

3. The facts in Paragraphs A, B and/or C.



## **EXHIBIT "B"**

### **Terms of Probation**

1. Respondent's conduct shall conform to moral and professional standards of conduct and governing law. Any act of professional misconduct by Respondent as defined by New York Education Law §§ 6530 or 6531 shall constitute a violation of probation and may Subject Respondent to an action pursuant to New York Public Health Law § 230(19).
2. Respondent shall maintain active registration of Respondent's license (except during periods of actual suspension) with the New York State Education Department Division of Professional Licensing Services, and shall pay all registration fees.
3. Respondent shall provide the Director, Office of Professional Medical Conduct (OPMC), Hedley Park Place, 433 River Street Suite 303, Troy, New York 12180-2299 with the following information, in writing, and ensure that this information is kept current: a full description of Respondent's employment and practice; all professional and residential addresses and telephone numbers within and outside New York State; and all investigations, arrests, charges, convictions or disciplinary actions by any local, state or federal agency, institution or facility. Respondent shall notify OPMC, in writing, within 30 days of any additions to or changes in the required information.
4. Respondent shall cooperate fully with, and respond in a timely manner to, OPMC requests to provide written periodic verification of Respondent's compliance with the terms of this Consent Order. Upon the Director of OPMC's request, Respondent shall meet in person with the Director's designee.
5. Respondent's failure to pay any monetary penalty by the prescribed date shall subject Respondent to all provisions of law relating to debt collection by New York State, including but not limited to: the imposition of interest, late payment charges and collection fees; referral to the New York State Department of Taxation and Finance for collection; and non-renewal of permits or licenses [Tax Law § 171(27); State Finance Law § 18; CPLR § 5001; Executive Law § 32].
6. Respondent shall comply fully with the July 8, 2006, Stipulation and Order of the Minnesota Board of Medical Practice (hereinafter "Minnesota Board") and any extension or modification thereof.
7. Respondent shall provide a written authorization for the Minnesota Board to provide the Director of OPMC with any/all information or documentation as requested by OPMC to enable OPMC to determine whether Respondent is in compliance with the Minnesota Order.
8. Respondent shall submit semi-annually a signed Compliance Declaration to the Director of OPMC, which truthfully attests whether Respondent has been in compliance with the Minnesota Order during the declaration period specified.
9. Respondent shall comply with this Consent Order and all its terms, and shall bear all associated compliance costs. Upon receiving evidence of noncompliance with, or a violation of, these terms, the Director of OPMC and/or the Board may initiate a violation of probation proceeding, and/or any other such proceeding authorized by law, against Respondent.
